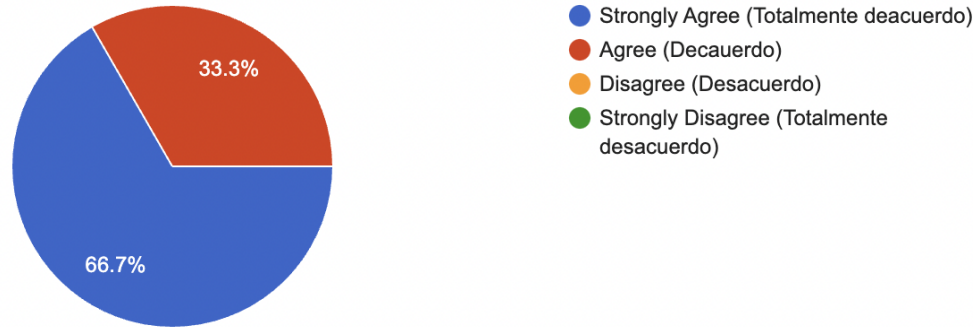
Aurum Preparatory Academy’s (“Aurum Prep”) mission is to educate all of its students grades 6 - 8 to succeed in high school, college, and life and to serve as the next generation of moral leaders. Aurum Prep is in its fifth year of operation and intentionally serves a traditionally underserved population. Our unduplicated pupil count for free or reduced lunch and English learners was 87%. This year we were able to add to the capacity of our leadership team with the addition of a second Assistant Principal.

Reflections: Successes

- Aurum Prep had some definitive wins this year with regard to some of our predefined goals. From year to year, some of the predefined goals include:
1. On average more than 80% of our students passed their classes.
 2. 75% of students meeting or exceeding their NWEA growth targets in Math and ELA and exceeding the Map Growth Norms in % classes.
 3. 75% of students stating they are proud to be at Aurum Prep.

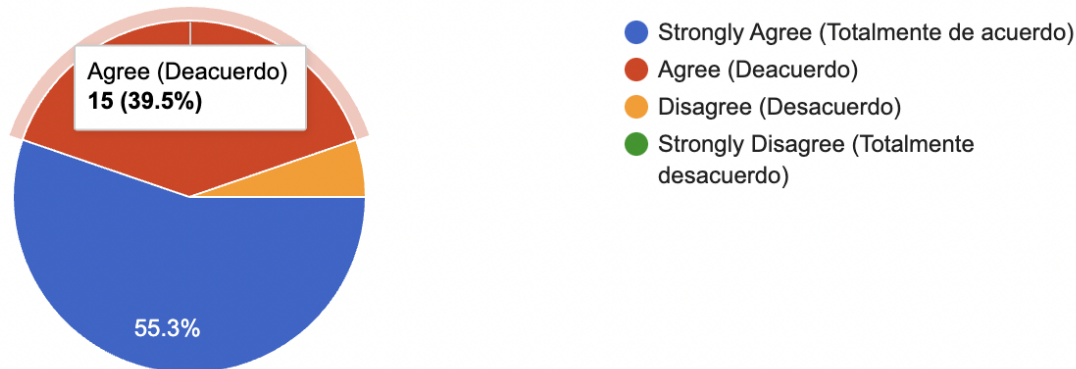

In terms of successes, this has been our most academically successful year by many measures. We have achieved our highest passage rates, we have exceeded the Map School Growth Norms in 5 out of 6 content areas, and we have the highest absolute performance on the SBAC since our inception. Specifically, we saw a modest overall increase in ELA from 27% to 28%, however, we saw a dramatic increase in Mathematics from 11% to 22%. These data points suggest that we made significant academic progress with regard to the extent to which our students are learning, our two assistant principal model can in part be attributed to this growth. Our students are generally excited to be at Aurum Prep as measured by our survey data in which more than 75% stated they were proud to be at the school. This can in part be attributed to events we do to build culture such as: onboarding during the first week of school, community circle, clubs, advisory competitions such as the door decoration contest, athletics, week without walls, and events such as school dances. Lastly, we continue to maintain an operationally and fiscally sound organizational structure. We have exceeded our budgeted fund balance and also we have maintained compliance with our authorizer.

Reflections: Identified Need

Aurum Prep also had some definitive struggles this year with regard to some of our predefined goals. From year to year, some of the predefined goals include:

1. Attendance - 90.79%
2. Chronic Absence Rate- 35%
3. Staffing

With regards to areas of improvement, attendance certainly stands out as one of the highest priorities. This past year, we only achieved a 90.79 attendance rate while our goal was 93% or higher. Moreover, we had a staggeringly high chronic absence rate at 35%. This suggests while we are making efforts towards getting students to school, our efforts have not been effective. We make daily calls, and send out letters, we also make home visits. We will need to develop a new approach. This also has other implications as the students with lower attendance tended to make less growth. Staff turnover and transitions were also notable contributors to some of the aforementioned issues as it is difficult to maintain instructional quality when there are shifts in instruction. This year we had transitions for a variety of reasons including but not limited to a significant number of staff resigning prior to the start of school. This caused us to have to cover a variety of classes with extra preps and through our leadership team.

LCAP Highlights

The LCAP for the 2023 - 2024 school year is centered around 3 primary goals:

1. Providing a rigorous and engaging academic program
2. Providing a welcoming and safe school culture
3. Ensuring a strong and sustainable organization

Within each of these goals, we have a variety of metrics to measure our progress towards that particular goal. For example, within academic progress we utilize both the Map assessment and the SBAC to determine both absolute performance and growth. After detailing the data for each of the measures of success we list the actions we are taking in each area in order to adjust appropriately in the upcoming year.

Engaging Educational Partners

A summary of the process used to engage educational partners and how this engagement was considered before finalizing the LCAP.

- Aurum Preparatory Academy has consulted with a wide variety of constituents in the planning process for this LCAP/Annual Review and Analysis. Specifically, we have:
1. Held parent meetings through our monthly “Cafelitos” (8/26/22, 9/30/22, 10/28/22, 11/18/22, 12/16/22, 1/28/23, 2/24/23, 3/31/23, 4/28/23, 5/26/23)
 2. Administered a survey to parents, students, and staff (11/14/23, 2/24/23)
 3. Held staff meetings (9/26/23, 11/7/23, 12/14/23, 2/20/23, 3/24/23, 4/3/23,)
 4. Held ongoing board meetings (8/25/22, 10/27/22, 11/29/22, 12/01/22, 1/26/23, 2/23/23, 3/23/23)

We worked with Silicon Schools to vet and interview a variety of educational partners. We ultimately partnered with Instruction Partners as an outside consultant. We then worked with families in our cafecitos and our outside consultant to further deliberate who might be a good fit and then ultimately made a decision as the best manner in which to proceed.

We also presented the [budget overview for parents](#) before determining our final LCAP plan.

The highlights from the feedback provided were that our rigor was not high enough in the classes and that we need to prioritize planning. Meaning that, while we have a rigorous curriculum, the tasks that our staff are often putting in front of students isn't rigorous enough. We also need to improve the stability of staffing in the organization as turnover has been a prevailing issue. A few major shifts from our planned actions and implementation were that we were not able to regularly hold Data Driven Instruction and we implemented Dreambox as a math intervention mid year rather than Khan academy.

Funds were allocated as planned with minor differences based on actuals vs. expected expenditures. We spent approximately 3K more for our math intervention plan.

Aurum Preparatory Academy made notable progress towards achieving progress as it pertains to providing a rigorous and engaging academic program. Our absolute growth for Math on the SBAC nearly doubled our performance in the last year. Moreover, our growth on the MAP assessment with regard to school growth norms was exceeded in all ELA and Math classes with the exception of 6th grade math which was very close.

We will focus on implementing data driven instruction meetings with consistency so that we can more effectively diagnose student needs on a regular basis.

This year one of the key differences between the planned actions and the actual implementation was centered in the RISK team meeting frequency. Due to staff turnover, we found it difficult to maintain these meetings with regularity because our team was often covering other duties.

In the previous academic year, we completely refined our model for managing culture. We ensured that all staff were trained on the No Nonsense Nurturer model. Furthermore, we also kept elements of our PBIS systems such as clubs, community circle, and advisory. The fostering of these small communities has allowed us to also keep track of student progress by advisory with the advisor leveraging their relationships with the student and family to move several of the goals within this goal area.

We have fallen quite short of our attendance expectations. Chronic absenteeism is a pervasive issue.

We will prioritize regular RISK team meetings to keep track and problem solve on this issue going forward.

We were able to meet most of the goals within this category, however, we were unable to meet the Board membership goal and the clean audit goal.

Funds were allocated mostly as planned with minor differences based on actuals vs. expected expenditures. Additionally, we did not have staff conduct home visits and instead allocated those funds to general positive attendance training.

We know that when there is proper oversight and resources allocated to priority areas that progress can be readily achieved. Therefore, we allocate a significant amount to ensure that we have the proper resources and operations to ensure the future development of Aurum Prep specifically with respect to the progress of our FRL, EL, and Foster Youth Students.

While we did recruit two new Board members this year we have fallen short of the total of 7. Moreover, we have not been able to develop systems for consistent attendance taking in after school until mid year. We are prioritizing these actions going forward.

We were unable to recruit the number of Board members and also we had an audit finding for after school attendance taking. Introduction and Instructions

These actions are being provided on an LEA-wide basis and we expect/hope that all students with less than a 100 percent attendance rate will benefit. However, because of the significantly lower attendance rate of low-income students, and because the actions meet needs most associated with the chronic stresses and experiences of a socio-economically disadvantaged status, we expect that the attendance rate for our low-income students will increase significantly more than the average attendance rate of all other students. (Measurable Outcomes [Effective In])
